Preamble

WHEREAS, Thirumathi Kaliammal Palaniappan Educational & Charitable Trust submitted an application in the name of Kalaiammal College of Education. Recognition was granted to the institution on 17.11.2005 at No.6, Anna Salai, New Bus Stand Backside, Karur-639002, Tamilnadu.

AND WHEREAS, meanwhile the institution submitted an application for M.Ed course on 31.12.2007. The application was processed and inspection of the institution was conducted. Recognition to the institution was refused on 21.04.2009. Aggrieved by the rejection order the institution preferred an appeal. The Appellate Authority vide order dt.07.8.2009 confirmed the order of SRC.

AND WHEREAS, the institution filed court case in W.P. No. 9358 of 2009. Meantime, NCTE-Hqrs. has forwarded a copy of notice received from the Hon'ble Madurai Bench of Madras High Court with a direction to take action since the case was set down for hearing on 29.1.2010. Accordingly, a reminder letter was issued to the Counsel on 11.2.2010 to defend the case.

AND WHEREAS, thereafter, the institution has forwarded a copy of court order dt. 24.04.2010 in W.P.(MD) No. 9358 of 2009 quashing the appeal order of appellate authority. The court has ordered as follows:-

"......In such view of the matter, the impugned order of the first respondent, dated 7.8.2009 stands set aside. The writ petition stands allowed with a direction to the second respondent to cause fresh inspection on the petitioner's institute in the new premises with the team consisting of the technically qualified persons and pass appropriate orders regarding the grant of recognition to the petitioner institution to run M.Ed course along with the application of the petitioner dated 9.9.2008 followed by reminder, dated 31.3.2009 seeking permission to shift the B.Ed and D.T.Ed courses from the rental premises at no. 6, Anna Salai, New bus Stand Backside, Karur-639002 to the present constructed placed S.F.No.305/1, pavithiram village and post, Aravakuruchi Taluk, Karur District and such exercise shall be completed within a period of eight weeks from the date of receipt of copy of this order".

AND WHEREAS, In obedience to the court direction, the inspection of the institution was carried out on 19.7.2010. The Committee in its 194th meeting held on 21st-22nd July 2010 considered the VT report of the institution, VCD and other related documents along with the original file of the institution and decided to continue recognition accorded to both the institutions viz. Kalaiammal College of Education (APS04013-B.Ed) and Aasee College of Education (APS04903-B.Ed) Accordingly, decision of the SRC was informed to the institution on 31.08.2010 & 01.09.2010.

AND WHEREAS, Meanwhile a copy of letter from Tamilnadu Teacher's Education University No.TNTEU/R/Affln/Misc/2011/207 dated 18.02.2011 sent to the college stating as follows:

"The mailing address of the college is maintained as per the address mentioned in the unconditional order given by the NCTE. If you intend to effect change of address of the college, the NCTE approval for the same is mandatory.

Further, from the letter Heads of Aasee College of Education and Kaliammal College of Education it is noticed that both the colleges are having the same official address as S.F.No.305/1, Karur, Covai Road, Pavithiram Post, Karur-639002 with same phone address.

Your explanation should reach the undersigned within 15 days from the date of receipt of this communication failing which appropriate action will be taken in the matter".

Note: In 194th SRC meeting held on 21st-22nd July, 2010 decided to continue recognition to the following:

- Kalaiammal College of Education, Karur (APS04013 for B.Ed course.
- Aasee College of Education, Karur (APS04903) for B.Ed course.
- Aasee Teacher Training Institute, Karur (5030) for D.T.Ed course.

Thereafter recognition for M.Ed course was granted by SRC in 197th meeting held on October 2010. Accordingly recognition order was issued to the institution on 20.10.2010.

As per decision of SRC, continuation of recognition was issued on 01.09.2010.

AND WHEREAS, as per court order dt. 20.04.2010 request by Kaliammal College of Education, Aasee College of Education & Aasee Teacher Training Institute has to be considered and decision has to be taken for <u>shifting of premises</u>.

AND WHEREAS, the SRC in its 203rd meeting held on 31 March & 1 April 2011 considered the VT report of the institution and other related documents along with the original file of the institution for shifting to new/permanent premises from No.6, Anna Salai, New Bus Stand Backside, Karur-639002 to the new address S.F.No.305/1, Pavithiram Village and Post, Aravakauruchi Taluk, Karur-639002 and decided to permit shifting to new premises under intimation to the university.

NOW THEREFORE, permission is hereby accorded to Kalaiammal College of Education, No.6, Anna Salai, New Bus Stand Backside, Karur-639002, Tamilnadu to shift its premises to the new location / building at Kalaiammal College of Education, No.305/1, Pavithram Village and Post, Aravakauruchi Taluk, Karur-639002, Tamilnadu.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Further, the institution has submitted affidavit on 27.01.2015, as per regulations 2014 and the revised order for the academic year 2015-16 is as under:

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution Kalaiammal College of Education, No.305/1, Pavithram Village and Post, Aravakauruchi Taluk, Karur-639002, Tamilnadu has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.

- 3. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
 - I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- **4. NOW THEREFORE**, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **Kalaiammal College of Education**, **No.305/1**, **Pavithram Village and Post**, **Aravakauruchi Taluk**, **Karur-639002**, **Tamilnadu** for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to fulfilment of the conditions mentioned herein before 31.10.2015
- 5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - Sanctioned programmes along with annual intake in the institution:
 - m) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - n) Name of faculty members who left or joined during the last, quarter:
 - o) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - p) Fee charged from students;
 - q) Available infrastructural facilities;
 - r) Facilities added during the last quarter;
 - s) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - t) The affidavit with enclosure submitted along with application.
 - u) The institution shall be free to post additional relevant information. if it so desires.
 - v) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
